Williamson County Canvas August 2022 Election

Canvas size: 43 homes

Targeted Voters: 127 all deemed eligible in August 2022 election per WC Voter Rolls

Williamson County Areas Canvassed: Fairview, Brentwood, Franklin, Thompson Station

- Sampling of homes selected where one or more people in that location have a permanent (not temporary) Change of Address filed nationally with USPS by 6-1-2022 (going back up to 4 years of history) moving to another state or at least another county (excluding those who moved to states AP, AE, ... that represent military addresses.)
- Canvas done September/October 2022
- Analysis for this report conducted July 2022 through January 2023
- Data review covered elections from 2008 – Present



Williamson County Canvas August 2022 Election

Canvas size: 43 homes

Targeted Voters: 127

- How many registered voters at this address?
- Did you vote in the August 2022 election? Mail-in or Early or Election Day?
- If another name was registered at the address, do you know them?
Are they still here?
If they moved, do you know when they moved?
- Number of Mail-in ballots requested? Number received?
Number received for people not at this address?

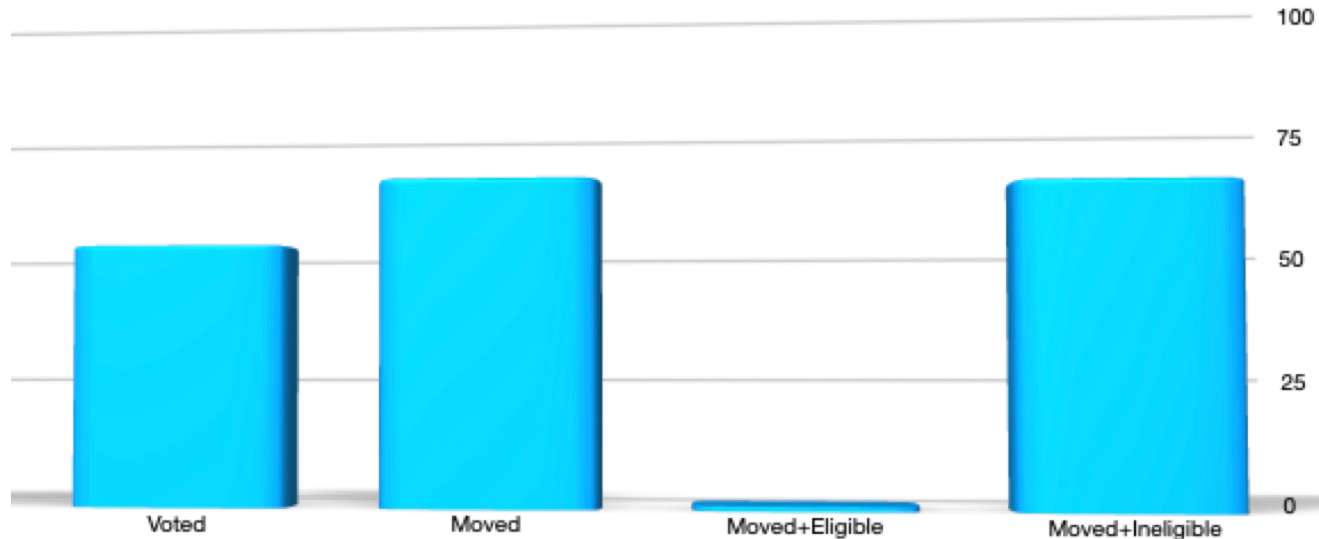


Williamson County Canvas August 2022 Election

52% of the Voters Voted

65% of the Voters had moved per NCOA. (81 reported and we identified 2 additional.)

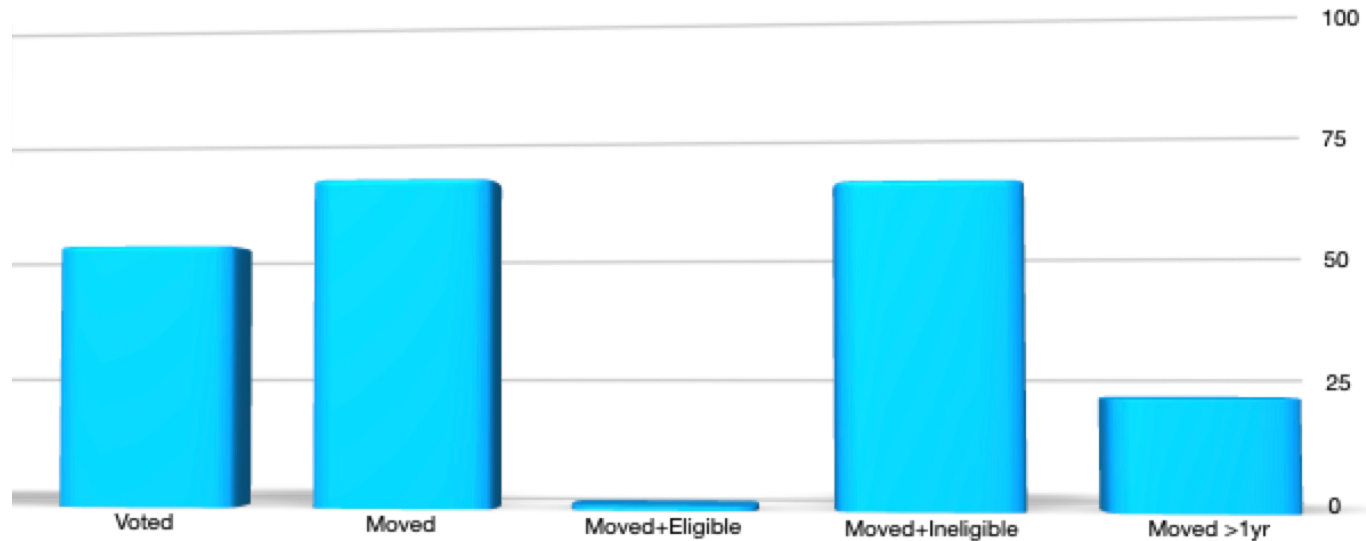
64% of the Voters had moved prior to July 2, 2022. (Ineligible to vote from that address.)





Williamson County Canvas August 2022 Election

22% of all Voters moved more than a year ago. (35% of all who moved.)
Yet State Elections Coordinator has stated NCOA sweep is done every year.



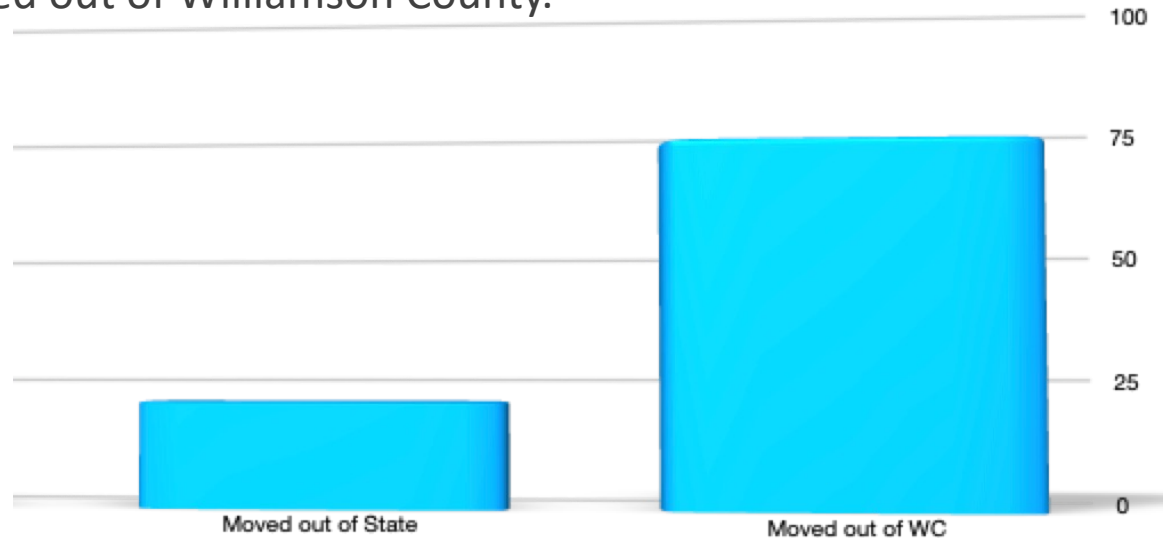


Williamson County Canvas August 2022 Election

Of those who moved...

21% of the Voters had moved out of state.

An additional 51% had moved out of Williamson County.



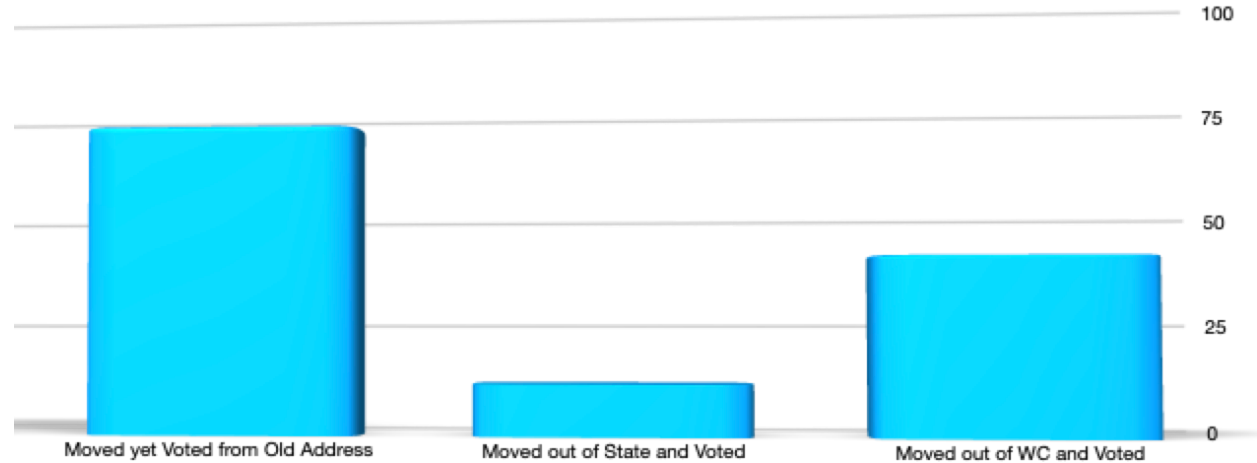


Williamson County Canvas August 2022 Election

71% who MOVED prior to cutoff, VOTED from their Old Address.

41% MOVED out of Williamson County prior to cutoff, stayed in TN, yet VOTED from their Old Address.

12% MOVED out of TN prior to cutoff yet VOTED from their Old Address.





Williamson County Canvas Voter Roll Analysis

Analysis of Voter Rolls over time found:

- State Elections Coordinator says NCOA run annually. Data suggests this is not true.
- Registration date changes in the database moving voter to “eligible” registration date range
- Abnormal numbers of registrations on Sundays and holidays (>20 years of data reviewed)
- Enormous spikes on last date of eligibility before an election (>20 years of data reviewed)
- General data practice issues (Williamson County and State)
 - Re-using Voter Numbers
 - Changing numbers without linking history
 - Active switch to inactive – How long? When removed? In other database when removed?
 - Coding Accuracy Support System (CASS) should also be run regularly to catch invalid addresses and should be run prior to National Change of Address (NCOA)
 - Missing logical checks at input – Example: Nonsense ages (example: Birth year 0204, Negative age, Registration date same year as birth year)

SUMMARY

- Tennessean and Williamson County votes are not carrying their proper weight due to the ineligible votes in the system.
- This sampling proves a full investigation of our election systems is warranted.
- Are laws being broken? Are laws being enforced?
- Voter Rolls have many errors and are not being cleaned per the State and US statutes.
- Data management and governance practices are not following industry standards.
- Statements made by our elected and appointed officials claiming clean rolls are not representing the truth that their own data shows.
