Williamson County School Board

There were no meetings this week; the next school board meetings are August. Policy committee August 5th, Work Session August 15th, full Board meeting August 19th.

I mentioned earlier that I had emailed **Superintendent Golden** to clarify the district's position on Title IX. We went back a forth and finally had a phone conversation. We both agreed that the injunctions against the new rules is now the law. I was concerned that WCS would follow the new rules if the injunction that includes Tennessee was overturned.

Superintendent Golden was very clear about WCS position on the new Title IX regulations and I am quoting directly from his last email to me. *Bill, thanks for the conversation yesterday. To give a short synopsis of our discussion, you asked me for a legal interpretation of the new regulations to reconcile what you pasted below from the website's summary. The most concise and clear answer I can give you is what I've already said in my July 1 email: we have never had plans to open girls' locker rooms and bathrooms to boys, and we still don't.*

He also made it clear, during our phone call, that he supports the lawsuit against the DOE that is currently protecting Tennessee from the new Title IX rules.

Williamson County Election Commission

The Commission met On Wednesday. There are no meetings scheduled for next week.

The Williamson County Election Commission (WCEC) met Wednesday, July 10th. Here are the highpoints.

- MIA Commissioner Doug Grindstaff attended the meeting.
- The absentee counting board members were approved and Chad indicated there will be about 300 absentee ballots to count.
- Jonathan Duda discussed a couple of new procedures that will be implemented at the August 1 election and again for the November 5 election.
 - First, at the close of the election in each vote center, in addition to returning the USB stick from each scanner/tabulator (which contains the tally of all votes from that particular tabulator) to the Election Office for county-wide tabulation, along

with the poll official documentation, the poll workers will open the ballot box area of the two vote center tabulators, pull out the blue ballot box in each where the voter's ballots are collected, ensure that any ballot that didn't fall into the ballot box is collected and placed in the ballot box and then the ballot box will be closed and sealed. Poll watchers will be able to watch the process and notate the seal number of the ballot box for chain of custody purposes. A backup USB stick remains with the tabulator in the vote center.

- Second, the WCEC will conduct a traditional tabulation audit of the machines (specifics of this to come).
- Third, the WCEC will volunteer to also conduct a Performance audit, which will be done election night to document that all procedures that should be done by the WCEC during the election are/were done.
- Following the meeting, the WCEC held an open house for candidates to see and better
 understand how the machines work. Unfortunately, the candidates are not given the
 opportunity to inspect inside the machines.
- As an aside, the WCEC has given notice to county citizens that the election to fill the vacancy in District 10 of Commissioner David Landrum (which right now is temporarily being filled by Cheryl Brown), will be held on November 5th, along with the presidential election.
 - o Qualifying deadline is Thursday, August 15, 2024 at 12 noon.

Tennessee State Election Commission

On Monday, July 8th, the Tennessee State Election Commission (SEC) held its quarterly meeting in Nashville. Highpoints:

- A Williamson County citizen spoke to SEC commissioners concerning last year's discussion by the WCEC before the Williamson County Commission to secure the funds and approval to purchase the ES&S voting machines.
 - Several citizens had presented concerns previously to the SEC about inaccurately cited sources and misrepresentations of data the WCEC used to convince WC Commissioners to approve the purchase. But the SEC concluded that despite the evidence presented by citizens, the SEC did not address any of the WCEC's problematic statements and, surprisingly, the WCEC did not violate their oath of office.
 - The citizen was attempting to learn if the decision has been made by one SEC commissioner or if all the information was shared with all SEC commissioners and all commissioners participated in the decision.
 - The SEC has yet to respond back to the citizen.
- A discussion was held involving a Memphis-area candidate for US House of Representative who wanted to use a nickname on the ballots. It was approved with modifications.
- The Coordinator of Elections did NOT mention anything about his and the Secretary of State's recent letter to 14,000 individuals who are on various county voter rolls across the state asking for documentation that would better identify them as citizens. Elections Coordinator Mark Goins only reminded commissioners that early voting starts in Tennessee on Friday.
- The next quarterly meeting of the SEC in Nashville is October 14, 2024.

Williamson County Commission

There were two important meetings this week. On Monday was the monthly **full commission meeting** <u>agenda</u> <u>video</u>. I am copying commissioner **Mary Smith's** newsletter about that meeting and adding a few comments of my own. On Thursday, the **Planning Commission** met <u>agenda</u> Video.

Update from Monday Night's Meeting:

Despite efforts to delay the vote on the District 10 Commissioner vacancy until after hearing from the voters, a new County Commissioner, Mrs. Cheryl Brown, nominated by fellow D10 Commissioner Meghan Guffee, was appointed to replace David Landrum. Mrs. Brown has commenced her term, which will continue until the November 2024 general election, when District 10 voters will elect their commissioner for the remaining 4-year term.

Similarly, the decision regarding the District 3 school board vacancy has been deferred until after the August 1st election. Commissioner Greg Sanford recommended postponing the decision until August 12th. Subsequently, the winner of the August 1st election will be nominated to join the school board during their meeting on August 19th.

The last big item in front of the commission was regarding an intent to fund capital projects totaling more than \$34 million which included \$22.5 million for a library and rec center in Bethesda. While it is way past due to get a new facility for the citizens in the southern part of the county, we are also dealing with the imminent need for a new jail, juvenile justice center and alternative learning center with a current price tag of \$325 million. While I did attempt to amend the request to focus

solely on public safety capital requests, this ultimately failed. The additional bond debt being requested in the next few months will increase our debt by more than \$12 million. And, as a reminder, we have still not seen an intent to fund for the jail project.

With a county-wide property reappraisal looming, the commission may seek to raise property taxes to fund upcoming projects. It's our responsibility as the county's fiduciary arm to make tough fiscal decisions. I take this duty seriously. Despite encountering limited enthusiasm for any creative funding proposals, I remain committed to exploring alternative avenues beyond property tax hikes. My goal is to deliver top-notch services without overburdening our residents.

I understand we all have busy lives, but your input and support are crucial to maintaining the quality of life we cherish in our community. Please take a moment to share your concerns and inform others about important developments in our county.

Site Plan Review for the Fernvale Springs Non-Traditional Wastewater Treatment and Disposal System, on 223.08 acres, located off Caney Fork Road, in the 1st Voting District (5-2024-006) took up most of the meeting. After all was said, the Plan Review passed unanimously. All of the rest of the items on the agenda also passed without comment from the commission.

Hold signs at voting places. During early voting and on election day, we need people to hold signs at voting locations. It may be hard to believe, but many people who come to vote don't know much about any of the candidates. At the last election, I was holding a sign for a candidate and several people stopped to ask about her and some of them were very favorable after talking with us.

Attend and encourage others to attend any event put on by the candidate(s). Meet and greets, campaign kickoffs, debates and forums are great places for potential voters to size up the candidates. The more we get people out to see our candidates the better.

Talk to people at your church, service organization, Bible study, bridge club etc. We all need to be talking about the candidates and recruiting everyone we know to get informed and get involved. This is a group effort, and we all need to pitch in to ensure that our candidates become school board members and not also rans.

Write them a check. Campaigns aren't free. Flyers, yard signs, text messages, videos all cost money.
