# Williamson County Commission

There were **three** meetings of import this week. **On Monday,** there was a hearing on the proposed new facilities for the county jail and the juvenile detention center. There has been a lot of concern from we the people with regards to cost and location of these facilities. I was only able to sit in on the first hour because I had to get over to the school board meeting that started a 6:30 pm.

I am linking you to the power point presentation and all I have to say is that we were told that we have to have these facilities or we are out of compliance with state law and basically behind the times. <u>Here</u> is the presentation and if I get more info, I will pass it on.

This meeting **should have been recorded** and is one more reason why we need more transparency from our county.

**On Thursday**, the commission approved the 24-25 county budget and <u>here</u> is the packet of resolutions and budget info. <u>Here</u> is the video.

There was a **short special session** just prior to the meeting to approve a resolution to forgive the Energy Savings Program debt payment by the school district for one year in the amount of \$1,141,922. The Energy Savings Program was an upgrade to school district buildings to make them more energy efficient. Those upgrades included windows, insulation and the like and was funded by issuing bonds. Each year, the school district gives back the interest on the bonds to the county and this year the county is forgiving the debt payment above.

We've been talking about the school budget for several months that started with a spending to revenue gap of \$25+ million. Now we have a budget that actually has a surplus and it looks like below.

After whittling down the \$25+m the last \$7,585,123 was taken care of with teacher's salaries (\$1,988,956), technology (\$3,999,800), office of principals (\$454,445) and the debt forgiveness (\$1,141,922).

#### RESOLUTION FIXING THE TAX LEVY IN WILLIAMSON COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 2024

SECTION 1. BE IT RESOLVED by the Board of County Commissioners of Williamson County, Tennessee, assembled in regular session on this 20<sup>th</sup> day of June, 2024, that the combined property tax rate for Williamson County, Tennessee, for the fiscal year beginning July 1, 2024, shall be \$1.88 on each \$100 of taxable property, which is to provide revenue for each of the following funds and otherwise conform to the following levies:

- **SECTION 2. BE IT FURTHER RESOLVED, that** certain revenues including the county's portion of local option sales tax and interest income are allocated at the designated amount in this document to the respective funds.
- **SECTION 3. BE IT FURTHER RESOLVED**, all revenue collected from the business tax for the 2024-25 fiscal year designated for the Highway/Public Works Fund that exceeds \$3,550,000, and all revenue collected from the wheel tax for the 2024-25 fiscal year designated for the Highway/Public Works Fund that exceeds \$5,000,000, shall be designated to the Williamson County General Fund.
- **SECTION 4. BE IT FURTHER RESOLVED,** that all Resolutions of the Board of County Commissioners of Williamson County, Tennessee, which are in conflict with this resolution are hereby repealed.
- **SECTION 5. BE IT FURTHER RESOLVED**, that this Resolution shall take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.

#### Williamson County School Board

There was a full board meeting on Monday. Agenda video

Superintendent Golden talked about safety in our schools to include all students feeling safe in the classroom setting. He talked about bullying and the fact that it was highest in the middle schools. He mentioned that addressing bullying was a very high priority. The board Extended Golden's contract for one year which, with the 6% increase, would make it **\$348,740**. Vote was 9 yes, and two no who were Donna Clements and Dan Cash.

**The budget** got a lot of discussion. It turns out that we have gone from a \$25+ m gap to a \$193,296 surplus. There was a long discussion on whether or not to use this surplus to increase art teacher's pay. An amendment was put forth by Jay Gailbreath that the surplus be used for the art/band teachers. It was voted down with the idea that it will be taken up later. Rick Wimberly mentioned that all teachers and staff are underpaid without exception and Eric Welch mentioned that there are a number of teachers and staff who go above and beyond their job description who should be included as well. The amended budget passed 11-0

**The Library policy** got a fair amount of discussion which was mostly a re-hash of past discussions. It passed 8-3, Welch, Haugh, and Wimberly were the three nos.

**PECCA is** new to me, and you can read the policy and memorandum in the agenda and watch the video. Basically, it is teacher input and this year they have changed the amounts of supplemental income for a few job descriptions including band and drama. It passed 10-1 with Gailbreath voting no.

### **Point of clarification**

After last month's school board meeting, I published the following on 5/24: Several board members spoke about this policy. **Rick Wimberly** noted that we have 50 librarians in the district and each of them, in order to evaluate 15% of their collection, would have to read approx. 1,800 each year. **Eric Welch** noted that the district has been notified that 118 books are ready to be challenged (I checked with the superintendent's office and got this response: *"Williamson County Schools does not have a current book challenge. You can email Mr. Welch to see who he was talking about during the meeting."*) I neglected to contact Mr. Welch before publishing my 5/24 Recap. | should have contacted Mr. Welch and gotten clarification from him.

To be clear, this is what he said:

"We've already had a group who has submitted a list to us of 118 books that they disagree with, that exists". He used the terms submitted and to us. Go to approx. 2:27:01 here to see for yourself.

Since then, I have communicated with him and asked him for further clarification and this is what I got from an email he sent:

"I never stated that WCS had received that many formal book challenges, but that there were groups who'd indicated that they had existing lists that length. The number I referenced refers to an ongoing lawsuit and I can't expand beyond that. Another example is when I testified at the Capitol and another speaker referenced more than one hundred books they'd identified and were ready to challenge. Had you asked me this earlier & directly I would have happily clarified for you, but you did not. You misunderstood and you not-so-subtly suggested I was lying in both your email to me and your MFL update."

I asked for further clarification and, until now, I've gotten no reply. I asked him to explain what he meant by **"submitted"** and **"to us"** and he has not responded. So, as far as I'm concerned, the matter is closed and I accept his clarification, such as it is.

There are no school board meetings in July.

## Williamson County Election Commission

There were no meetings this week and none are scheduled for next week.

### **Board of Mayor and Aldermen (BOMA)**

#### School board election

All six republican candidates could use some help.

**The election is on August 1st. and early voting runs from July 12-27.** We need folks who are willing to do the following:

**Knock on doors for the candidates.** Face to face, person to person is very powerful. It lets people know that the election is important and why. It also allows the homeowner to ask questions and get clarification on the issues. As we get schedules from the candidates, we will be sending out a **signup genius for each candidate.** 

**Put up yard signs.** First, you can put a yard sign at your home (if you live in an odd district). Secondly, we may have a need for a few of us to put out signs for some of the candidates and finally, you can encourage friends and neighbors who live in an odd district to take a sign.

**Hold signs at voting places.** During early voting and on election day, we need people to hold signs at voting locations. It may be hard to believe, but many people who come to vote don't know much about any of the candidates. At the last election, I was holding a sign for a candidate and several people stopped to ask about her and some of them were very favorable after talking with us.

Attend and encourage others to attend any event put on by the candidate(s). Meet and greets, campaign kickoffs, debates and forums are great places for potential voters to size up the candidates. The more we get people out to see our candidates the better.

**Talk to people at your church, service organization, Bible study, bridge club etc.** We all need to be talking about the candidates and recruiting everyone we know to get informed and get involved. This is a group effort and we all need to pitch in to ensure that our candidates become school board members and not also rans.

Write them a check. Campaigns aren't free. Flyers, yard signs, text messages, videos all cost money.
