Williamson County Commission

There were four significant votes at Monday's meeting [agenda video](#):

1. The resolution on 5G tower setbacks with an amendment that removed residential from the wording passed. This means that 5G towers must be placed at least 1,500 ft from any school building where children attend. There is no setback required for residential property. There were two reasons for this. 1. A 1,500 ft setback for residential, as explained by attorney Kristi Ransom, would severely limit the available locations for cell towers and 2. It could run afoul of the Communications act of 1996.
2. The Urban Growth Boundary Plan was rejected and sent back to the coordinating committee.
3. The hand marked paper ballot feasibility study was deferred to the March meeting to allow commissioners to study the issue further.
4. The appointment of sheriff was deferred to the March meeting when the results of the primary election will be known.

There were a lot of people at the meeting and most of the public comments were against the Election Commission feasibility study. Since that meeting, new information has come to light about **Jennifer Morrell**, the CEO of **The Elections Group**. We have been saying that she is very left leaning and part of the deep state and its control over information. We now have evidence to support this contention.

Here is the important except from the report:

Today, we have evidence that a private meeting was organized by CISA officials on November 3, 2020, at 3:30 PM Eastern Time with select members of a secret "Election Security Initiative."

This was an exclusive meeting of CISA officials and their exclusive election Partners. This was held late in the afternoon on Election Day. It reportedly lasted for a half hour.

The list includes over 200 names of individuals, government entities, private businesses, media outlets, and at least one tech giant. The list includes a curious mix of members from Dominion, **ES&S**, ERIC Systems, Amazon, Runbeck, Microsoft, Scytll, several Secretary of State offices, the Associated Press, Amazon, and leftist groups.

Several high-profile individuals were invited to the call, including **Jennifer Morrell with The Elections Group**, **Ryan Macias** with The Lafayette Group, **Eric Coomer** with Dominion, and **Joselyn Benson**, the controversial Michigan Secretary of State.

For those that aren't aware of what occurred last night at the Williamson County Commission meeting where the election commission's resolution to hire The Elections Group to perform the long-awaited hand-marked paper ballot feasibility study was deferred to the Commission's March 11th meeting, here are the particulars:

- When the resolution came up for discussion, Commissioner Gregg Lawrence said:
 - He and many commissioners had received an abundance of emails over the weekend on this issue which he had yet to digest; he wants more time to go over them;
 - He was concerned that the \$100,000 was too much for a study and he was also concerned there was only one bid. He suggested to defer the resolution until their March meeting (March 11th).
- Then Commissioner Mary Smith added that she had spoken with Jonathan Duda, WCEC Chairman, saying she wanted to see what the 19 Tennessee counties that currently use hand-marked paper ballots have done. She also said:
 - There is current legislation in the General Assembly (HB1799/SB1706) that may mean The Elections Group may not be an approved vendor for election-related work in Tennessee and she wants to see how the legislation progresses before making a decision;
 - She also does not want to spend \$100,000 on the study.

Speaking of The Elections Group, here is news that is moving today concerning Jennifer Morrell, CEO of The Elections Group: [FOIA Documents Reveal Secret 2020 Election Day Meeting](#) Kind of looks like The Elections Group is an active participant in all the targeting of real election security thanks to her consulting relationship with the Cybersecurity & Infrastructure Security Agency (CISA) which has gone rogue since its founding. It's now colluding with Big Tech and government-funded third parties to conduct censorship by proxy and cover up CISA's unconstitutional activities.

Finally, the key message of Frank Limpus, founder, Tennessee Voters for Election Integrity, during the meeting's public comment time:

“Jonathan Duda says the WCEC isn’t equipped to perform a study? So, why doesn’t our election commission pull together a bi-partisan committee of election-knowledgeable citizens to collaborate with WCEC election commissioners and election officials from the 19 Tennessee counties that have already implemented hand-marked paper ballots. Regardless of the size of these counties, they’ve already crossed all the bridges and can offer WCEC real insights into adding HMPBs into our voting mix. This ain’t rocket science here. Pull together the group, set the questions needing answers, talk with all 19 counties and then site visit, say, the top five for best practices. Then implement. There are a lot of ways to address this challenge without spending \$100k. Besides, isn’t that what the network of election commissions are for? To share information/best practices with their colleagues?”
