The monthly **Board Meeting** is set for Tuesday the 16<sup>th</sup>. We need to get a good attendance at this meeting as we are continuing to pressure the board to create a flag policy, take sexually explicit books out of the schools and 5G towers close to schools (see WCC report below for an update on 5G).
