







QUICK BACKGROUND: LEGISLATION

1993: "MOTOR VOTER" – NATIONAL VOTER REGISTRATION ACT

- To facilitate voter registration when sign up for driver's licenses.
- Citizenship documentation not required; only attest.

2002: HELP AMERICA VOTE ACT (HAVA)

- Hanging chads > mandated process improvements > computers/machines.
- U.S. Election Assistance Commission (EAC):
 - Disburses funds for updating equipment, election procedures;
 - Certifies election machines; but to 2005 standards.

2021: BIDEN'S OPEN BOARDERS AND EXECUTIVE ORDERS

- 10+ million illegal aliens since Biden assumed office.
 - Dispersed across USA, especially "red" states.
 - Every state (except SC) issues DL's to noncitizens; 19 states to aliens.
- 3/7/21 Biden's EO #14019 ordered every government department and federal employees to use federal resources to – in essence – get-out-the-vote.
 - Violates multiple federal laws.
 - Executive branch has no constitutional authority to voter registration.

2025: SAFEGUARD AMERICAN VOTER ELIGIBILITY (SAVE) ACT

- Reverse Biden's moves.
- By law only U.S. citizens may vote in federal elections. But law is toothless.
 - Illegal voting tracked: Mass., Ohio, Virginia, Arizona, California, Illinois, New Jersey, North Carolina, Pennsylvania.
- SAVE requires proof of US citizenship in order to vote in federal elections.
 - Passport, birth certificate, REAL ID, military ID, govt.-issued photo ID with US citizenship photo, or vital records in birth state.
- Provides states a federal database to clean their voter rolls, remove non-citizens.
- Passed US House 4/10/25; now before Senate. Might not go forward.

2025: PRESERVING & PROTECTING THE INTEGRITY OF AMERICAN ELECTIONS

- Citizenship verification required, plus federal databases for verification.
- Voter-verifiable paper ballot – hand-marked paper ballots.
- Directs updating of Voluntary Voting System Guidelines 2.0, security standards.
 - ONLY 1 HART MACHINE MEETS THESE 2.0 STANDARDS! (1.0 = 2005)
- Enforce/prosecute election crimes.
- No counting ballots after election day.
- Fully repeals Biden's EO #14019 – "Get out the vote."

SPECIFIC HELP FOR TENNESSEE COUNTIES

- Increases EAC standards/testing for machines from VVSG 1.0 (2005) to 2.0 (2021).
 - Our machines have spent 20 years at 1.0. But your smartphone.....
- Requires voter-verifiable paper ballot without bar code.
 - No one can verify their selections on current ballot.
- EAC & Homeland Security: Report security in voter registration & voting process.
 - Have no information about Embry Consulting. (91 of 95 counties)
- Prohibits lobbying/election support by organizations receiving foreign funds.
 - Includes NGOs (non-governmental organizations).
- Recommendation... not enforced demand.
- BOTH SEC AND WCEC ARE IGNORING THIS EO.

2025: MAKE ELECTIONS SECURE AGAIN (MESA) ACT TO CODIFY PRESIDENT TRUMP'S ELECTION EO

- Texas Representative Pete Sessions.
- Demands hand-marked paper ballots for all federal elections and primaries.
- Bans electronic voting machines and universal mail-in voting.
- Paper poll books replace e-pollbooks.
- Government-issued photo ID; Rasmussen: 74% likely voters agree.
- No vote centers: Precinct voting w/1,500 max voters for hand-counting ballots.
- Limits early voting to three days prior to election day. (Thu/Fri/Sat)(Tues)?
- 2026: MESA Act with many of same steps to codify Trump's EO.

1. EO DRIVES SYSTEM CHANGES BECAUSE: VOTING MACHINES AREN'T/CAN'T BE INTERNALLY INSPECTED.

HIGHLY RISKY MACHINES

- State's weak research into machines: accept vendor documents, EAC blessing.
- Neither SEC nor WCEC internally inspect machines when enter state/county or prior to or after election.
 - No cyber experts, or IT techs allowed unfettered access.
- Only vendor can perform machine checks, software changes, upgrades.
- Proprietary software; no open-source software.
- WCEC does not perform EAC-advised hash verification before, after an election.
- Fulton County (GA) Raid: Ballots, ballot images, tapes, voter rolls.

2. EO STEPS WILL IMPROVE PERFORMANCE/SECURITY SINCE VOTING MACHINES ARE HIGHLY VULNERABLE TO HACKS, MALWARE, MAL-PERFORMANCE, BREAKDOWNS.

MACHINES CAN/HAVE DESTROYED TRUST IN ELECTIONS

- **2021: [Franklin Alderman election, TN](#)**
 - Machines stopped counting votes on tape; BMD-tabulator software conflict.
 - Dominion: "Erroneous code present;" how did that get there? L&A testing?
- **2023: [Monmouth County, NJ](#)**
 - ES&S machines double counted votes; gave losing candidate the win.
 - Later, ES&S admitted mis-programing error; recount loser now the winner.
- **2024: [DeKalb County, GA](#)**
 - Candidate received no votes in precinct she/husband voted.
 - Machine recount produced same results.
 - Hand count: System shorted candidate 3,049 of her 4,078 votes (74%).

 - Selections encased in QR or bar code (photo)

ADVANTAGES OF HAND-MARKED PAPER BALLOTS OVER BMDS

- HMPBs are voter-verifiable; BMD ballots are not.
 - Selections encased in QR or bar code (photo).
- HMPB voter knows who he/she voted for.
 - 60% BMD voters don't check ballot.
- HMPBs eliminate the BMD machines & speed up voting process (time study).
- HMPBs can be easily audited.
- HMPBs can be secured and numbered to affirm limited # in precinct (photo).

MORE ADVANTAGES OF HAND-MARKED PAPER OVER BMDS

- National Academies of Science, Engineering and Medicine recommends HMPBs.
- Cyber experts recommend HMPBs over BMDs.
- Paper costs far lower than machine costs.
- Two-thirds of the nation votes using HMPBs versus BMDs. (Map)


WHAT DOES THE NATION KNOW THAT TENNESSEE DOESN'T?

4. BUT VOTE CENTERS PREVENT ADDING HAND-MARKED PAPER BALLOTS WITHOUT ADDING MORE MACHINES

VOTE CENTERS DO NOT HELP VOTERS OR IMPROVE SECURITY

- Fewer vote locations: 42% less in 2020; force internet, machines, epollbooks.
 - Growing population, more voters in fewer locations, long lines, wait times.
 - Disenfranchisement of voters who travel away from neighborhood precincts.
 - Internet connection for registration; VPNs today are weak at best.
- Have not increased voter turnout. (WC 2004 Nov. election.)
- If we remain in vote centers & bring in HMPBs:
 - Unpredictable turnout, paper explosion, chain custody/cost nightmare.
 - Force ballot-on-demand to print every ballot for every race at every VC.
 - More machines that are uncertified by EAC. \$500,000+ in WC's 27 VCs.
- Best: Precincts @ 3000 voters; more precincts; enable hand counting to check.

CLEAN UP VOTER ROLLS; EXPLAIN VENDOR

- 2023: TVEI voter roll canvas of Williamson County revealed:
 - 65% of voters on voter roll at that time had moved.
 - Bad data practices: Reusing voter #s; changing #s without linking history.
 - State elections coordinator says NCOA run annually; data says not true.
 - No logic check at input: Nonsense ages (birth year 0204; negative age; registration data same year as birth year).
- Embry Consulting issue – Software handle voter rolls & vote registration system.
 - 91 of Tennessee's 95 counties; \$400,000+/year; NO contract.
 - NO credentials, security, training, certifications. TruthWire News series.



TRUMP'S EO & RECENT ACTS WILL HELP US GET TO AN IDEAL, SAFER, MORE SECURE AND ACCURATE ELECTION PROCESS

- Neighborhood precinct voting w/paper registration vs. vote centers.
 - No internet next to uninspected machines, no epollbooks.
- Removal of all ballot marking devices (except for 1 ADA).
 - Must retain tabulators because of law.
 - So, hand-count next day to check tabulator accuracy.
- High-security hand-marked paper ballots. (Arizona: Authentix)
- Reduce early voting period to 3 days then election day; save money. (\$192k+ ea.)
- Reduce number of voters per precinct (from 6k to 3k); (80% turnout = 2,400)
 - Increase # of smaller, neighborhood precincts; close to home.
- Work toward ultimate removal all machines to improve security.


- Get engaged: Or we'll lose our Constitutional Republic!





OUR IDEAL SYSTEM (PARTIALLY TESTED BY MAURY COUNTY)

- Return to neighborhood precinct voting, away from internet-heavy vote centers.
- Decrease size of precincts; increase the number of precincts. Hand count?
- Move back to paper registration/check-in like 2019.
- Remove BMDs, computer registration and registration voter cards (BMDs).
- Move tech from the machines to hand-marked paper ballots.
 - High-security, currency-grade, numbered, hand-marked paper ballots.
- Must count by tabulators; So, hand count all next day to **verify machine counts**.
- Clean up voter rolls; Transparency for Embryo voter roll/registration system.
- Live stream all voting/counting w/appropriately placed cameras.
- Post ballot images (no identification), poll official reports, stream videos online.

PROBLEM: HERITAGE SCORECARD - FALSE SENSE OF SECURITY

- It focuses on laws governing elections.... NOT:
 - Proven liabilities of our voting machines;
 - Total lack of transparency by vendors;
 - Administration of elections;
 - Behavior of commissioners against their code of conduct; or
 - Commissioners' follow-through on their promises.
- It only looks at a small sliver of "the big picture" of election integrity.
- Hargett/Goins have hijacked it to claim it says something it doesn't.
- Op-ed in News section of our website.

RECO: ROBUST MACHINE COST STUDY FOR FIDUCIARY WISDOM

- Perform 10-yr cost/benefit analysis of machines vs. paper.
 - Full life-cycle cost analysis of both systems documenting ALL costs.
 - Cost baseline including EEs & consultant costs, training, equipment, misc.
 - Adjust for inflation to normalize the data.
- Categories would include:
 - Hardware: Purchase, maintenance. Refresh, shipping, set-up.
 - Software: Licensing, updates, reprogramming, modifications,
 - Misc.: Training, storage, misc. vendor support, third-party consultancy, indirect county costs.

THIS IS NOT VOTER SUPPRESSION

- 2019 Heritage survey of ten years of turnout data in 50 states;
 - No negative effect on registration or turnout for any group.
- Voter laws in states (IN, KS, TN, WI, MS, TX...) because courts agreed they're "not discriminatory" and don't represent a tangible burden on voters.
- Census Bureau reports registration & turnout verify this:
 - 2012 Blacks had higher voter rate vs Whites nationally: 66.2% vs 64.1%.
 - 2016/18/20 Miss. higher turnout than CT, NY, DE. 67.7%, 54.2%, 70.3%.
 - 2020 national turnout (66.8%) higher than Obama 2008 (63.6%).
